 bylaws, updates about club activities, etc; **rather**, the blog is a place to post
 pictures, news articles about the success of events, interesting facts about
 club members, etc.;
- There was a discussion re: change "Newsletter Editor" to a "Media Editor" in the bylaws. (Any member may propose a Bylaws amendment, in writing, to the Board. The Board decides whether a proposed amendment is to be brought forward for a vote, and informs the membership of each such proposed amendment at least two weeks prior to the meeting at which it will be voted on.)

6. Start Date for New Class (July 27, 2011)

- Flyers for the new classes have been printed and will be available at Pride; besides being posted on the FCS website, we will encourage members to post on community boards, in bars, etc.;
- The format of the class will be decided at the July Board meeting;
- <u>Motion</u> (Neiheisel/Ainge) to give one free night of dancing to any dues-paying FCS member for each new member that s/he sponsors and brings to one of the free dance nights for new lessons. Motion passed.

8. SD Pride: July 16 and 17, 2011

- Mike Neiheisel will complete paperwork to register FCS for participation in both the parade and the Pride Festival;
- Mark Pumpkinthief is organizing FCS participation in the parade;
- Jason Ainge is coordinating the Pride Booth.

- 9. Badges and Graduation Certificates
 - Graduation certificates and badges are ready for graduation; however, the badges will be stoned at a future date.
 - The graduation dance is Saturday, June 11, 2011, at the Balboa Club.

10. Delegate for IAGSDC

- Ken Valdez will be the delegate; Peter Tognalli will be his alternate at the Friday, July 1, 2011 meeting in Atlanta.
- NYC's Time Squares will do a presentation for delegates re: hosting the 2014 Convention; our delegate will discuss FCS concerns re: projected costs of hotel rooms, food, etc. in NYC.
