1. SDSDA Report

- SDSDA Halloween Dance: participation in this dance is being "strongly" encouraged by the SDSDA.
a. Motion (Ainge/Brindamour) for FCS to purchase 8 tickets for the dance at a total cost of $\$ 120$. The tickets will be offered to FCS members; if more than 8 members ask for tickets, a lottery will be held. Motion passed.

2. Pass the Sea (PTS) 2012

- New gmail account has been created by Ken.
- 64 registrations have been received to date.

3. Media Coordinator

- Revamping of FCS website is ongoing.
- There are 56 friends in the new Facebook group.

## Old Business

1. Themes for Upcoming Dances

2. Anniversary Dance

- Need to check with Romney Tannehill to see if he needs sound equipment for the April $14^{\text {th }}$ dance.
- Motion (Neiheisel/Pumpkinthief): Try to book Eric Henerlau for the 2013 Anniversary Dance. Ask if he will call an afternoon dance in addition to the evening dance for the same price. Motion passed

3. Incentives

- Motion (Ainge/Pumpkinthief): Table incentives for angeling until May since we are not having difficulty with that issue now. Motion passed.
- Motion (Brindamour/E.Jackson): Starting with the new class next August, dues paying members and class members will pay $\$ 5$ on Wednesdays and non-dues
paying dancers will pay $\$ 6$. Motion passed.
- Motion (Valdez/Grimm): A discount of $\$ 5$ will be given to anyone who pays his/her dues in October. Motion passed.

4. Pride 2012

- Motion (Pumpkinthief/Brindamour): Allow a budget of $\$ 600$ for Pride marketing (excluding parade fee). Motion passed
- Pride booth in lower section costs $\$ 225$
- Pride booth in upper section costs $\$ 475$
